



Export customs code for energy storage containers

What are export codes?

Export codes are a set of identifiers used to classify goods for international trade. Different codes serve different purposes, aiding in export controls, customs duties and trade statistics. What is an ECCN (Export Control Classification Number)?

Can a container be used for an export declaration?

Containers specially designed and equipped for carriage by one or more modes of transport (excl. those with an anti-radiation lead covering for the transport of radioactive materials) Can be used for an export declaration.

Do export codes change?

Yes, export codes can change periodically due to various factors, such as updates to national security regulations, changes in product technology or international trade agreements. It's crucial to stay updated with the latest information to ensure accurate classification and compliance. Can I use the same export code for different countries?

How do I report shipments in the Automated Export System (AES)?

Report shipments in the Automated Export System (AES) when the value is more than \$2,500, or the item requires a license. Comply with U.S. law, where applicable. The Census Bureau offers a free, widely used online Schedule B search engine that can help you classify your products.

Who controls the export and reexport of "dual-use" items?

The BIS within the U.S. Department of Commerce has jurisdiction over the export and reexport of "dual-use" items (i.e., commodities, technology and software that have both civilian and military or proliferation applications). These controls are implemented through the EAR.

How do I classify products for export controls?

The third way to classify your products for export controls is to go to the source. You can contact the manufacturer, producer or developer of the item you are exporting to see if they have classified their product and can provide you with the ECCN. If they have exported the item in the past, it is likely they have the ECCN.
